# Subject: Information on Well Child Visits 0-21 years/Update to HEDIS Measure 2025

Summary: W30: Well Child Visits in the first 15 months Well Child Visits 15-30 months old WCV: Well Child Visits 3-21 years old

## **IMPORTANT CHANGE to HEDIS 2025:**

Beginning in the measurement year 2025, NCQA has removed telehealth <sup>1</sup> visits for well visit compliance. Well visits completed via telehealth or virtual visit will no longer count towards the HEDIS numerator.

Well child visits offer providers the opportunity to impact the health and development of their pediatric population. Key screenings and counseling should be presented to parents and guardians during the well visit.

Each well child visit should focus on prevention, early detection, and medically necessary treatment.

### What do you need to know?

### W30: Well-Child Visits in the First 30 Months of Life:

Children should have <u>at least 6 well visits</u> by age 15 months and should have <u>at least 2 more well visits</u> by age 30 months. The American Academy of Pediatrics recommends the following schedule of Well-Child Visits in the first 30 months of life.<sup>2</sup>

<ul> <li>3-5 days old</li> </ul>	<ul><li>12 months</li></ul>
<ul><li>1 month</li></ul>	<ul><li>15 months</li></ul>
<ul><li>2 months</li></ul>	<ul><li>18 months</li></ul>

### WCV: Child and Adolescent Well-care Visits:

Children ages 3-21 should have <u>a yearly well child visit</u>.

AmeriHealth Caritas Louisiana offers a *Care Card Incentive* to members who complete their Well-Child Visits:

- \$20 for completing 6 well visits from birth to 15 months
- \$15 for completing an annual well visit ages 2-20
- \$20 for completing an annual visit with a Primary Care Provider age 21 and older
